

The Wilson Center has multiple fellowship programs. At the moment, they are preparing to launch their China Fellowship which is a 1-year non-residential fellowship (August to August) focusing on China's impact on Asia or the United States across a wide variety of issue areas. The Wilson Center invites American scholars, practitioners, journalists and public intellectuals to apply. Fellows conduct research and write in their areas of interest, publish their research through the Wilson Center, and will have the opportunity to interact with policymakers and thought leaders in Washington. The Center accepts policy-relevant, non-advocacy fellowship proposals that build understanding of China and its impact for Asia and/or the United States.

This fellowship is available to U.S. citizens only, although they may have residency anywhere around the world. Candidates must have received a PhD or JD from an accredited university on or after January 1, 2009.

The next round of Wilson China Fellowship applications will open in April 2023. This year's fellowship application process will run from April 1st to June 15th.





Historical Research on the Practices and Institutions of Social and Natural Science

Letter of Inquiry due: March 16, 2023

The Alfred P. Sloan Foundation supports basic research and public understanding of science, technology, and economic behavior. They believe that historical scholarship is valuable to understand the contemporary context of scientific research and that historical scholarship can be critically important to informing current and future research and policy practices.

Grants of \$75,000 - \$250,000 will be awarded for original research in the history of science, technology, economics, and social science, focusing on areas of broad programmatic interest to the Alfred P. Sloan Foundation. Letters of Inquiry are invited for the following types of research project:

- **Faculty-led research projects** of up to \$250,000, with the aim of advancing original scholarship on a topic or theme of interest to the Foundation in the history of science, technology, economics, and social science
- **Dissertation improvement and completion projects** of up to \$75,000, to specifically support dissertation research expenses including travel, archival fees, and data collection, and up to one year of graduate student stipend (including summer funding, but not tuition) on a topic or theme of interest to the Foundation in the history of science, technology, economics, and social science.

Located in New York, NY, the Whiting Foundation provides targeted support for writers, scholars, and the stewards of humanity's shared cultural heritage. The foundation strives to support work that **deepens the human experience and broadens individual perspective**. Whiting is proud to help make a place in the world for these important contributions to art and understanding.

Whiting offers support for writers via the <u>Creative Nonfiction Grant</u>. The 2023 Whiting Creative Nonfiction Grant of \$40,000 will be awarded to as many as ten writers in the process of completing a book-length work of deeply researched and imaginatively composed nonfiction for a general readership. It is intended for multiyear book projects requiring large amounts of deep and focused research, thinking, and writing at a crucial point mid-process, after significant work has been accomplished but when an extra infusion of support can make a difference in the ultimate shape and quality of the work.


Projects must be under contract with a publisher in Canada, the UK, or the US by April 25 to be eligible. Contracts with self-publishing companies are not eligible. Writers must submit the following materials via the **online application** form by 11:59pm ET on Tuesday, April 25.



In 1925, Simon and Olga Guggenheim established the John Simon Guggenheim Memorial Foundation in memory of their late son, a promising young scholar who died at the age of 17. In his first letter of gift, Senator Guggenheim wrote that the organization's aim was to "add to the educational, literary, artistic, and scientific power of this country." The Guggenheim Foundation currently runs **one of the most prestigious fellowship programs in the world**. It offers fellowships to exceptional individuals in pursuit of scholarship in any field of knowledge and creation of any artform, under the freest possible conditions and irrespective of race, color, or creed.

Guggenheim Fellowships are intended for mid-career individuals who have demonstrated exceptional capacity for productive scholarship or exceptional creative ability in the arts and exhibit great promise for their future endeavors.

Competition Timeline:

Application portal opens in August

<u>Deadline to submit applications is in mid-September</u>

References will be contacted for recommendations in mid-November

Work example (if requested) is due mid-December

Notification of competition results set to all applicants in mid-April

Whether staying in a remote cabin in the wilderness, or a historic lighthouse in the Dry Tortugas, these programs provide artists the unique experience to work on projects of their choice, away from the distractions of everyday life.
